BARNUM LAKE DRAIN

Notice Is Hereby Given to you as a person owning lands liable for an assessment or a public corporation subject to assessment, that the Board of Determination will meet on **Monday, July 28, 2014, at 10:00 AM at the Holiday Inn, 12812 Harper Village Dr., Battle Creek, Michigan 49014** to hear all interested persons and evidence and to determine whether the Drain as prayed for in the petition dated August 18, 2011, for the maintenance and improvement of the Barnum Lake Drain pursuant to Act 40 of the Public Acts of 1956, as amended, is necessary and conducive to the public health, convenience or welfare, and whether said Drain is necessary for the protection of the public health of the Township of Leroy, Township of Newton, Township of Emmett, and the City of Battle Creek, and to further determine whether the addition and/or deletion of lands as recommended by a licensed engineer or surveyor will more accurately define the boundaries of the land benefitted by the Drain, and whether such addition and/or deletion of lands is just and equitable pursuant to Section 197 of Act No. 40, P.A. 1956, as amended.

A map depicting the proposed revisions to the boundaries of the Barnum Lake Drain Drainage District as recommended by a licensed professional engineer or surveyor is enclosed with this Notice (see reverse side).




