

RE: REGULAR TERMS OF COURT

As required by the provisions of MSA 27A.1513 and 27A.1501, in accordance with MCR 8.113;

IT IS ORDERED:

1. There shall be four regular terms of the court in each the city of Battle Creek and city of Marshall annually.
2. Each term shall commence in the respective city on the first business day in the months of January, April, July, and October.
3. Unless otherwise directed by the Chief Circuit Judge, the Circuit Court Administrator shall periodically develop a schedule assigning judges to sit in the respective court facilities within the circuit. A copy of the schedule shall be provided to each judge, posted in the Circuit Court Clerk's Offices in Marshall and Battle Creek, and filed with the Circuit Court division of the County Clerk's Office.
4. This order confirms the April 9, 1985, letter to the Circuit Court Clerk, attached, and becomes effective January 12, 1990.


Dear Marcus:

In accordance with the provisions of MSA 27A.1513 and MSA 27A.1501, please consider this as a reminder that there are four regular terms of the Court in each the city of Battle Creek and city of Marshall annually. Each term in each city commences on the first business day of the months of January, April, July, and October, and continue until the last business day of the months of March, June, September, and December, respectively.

This will also confirm that the three Judges of the Circuit Court rotate on a periodic basis between the city of Marshall and city of Battle Creek with two Judges regularly sitting in the city of Battle Creek. The Circuit Court Administrator periodically provides a rotation schedule of the Judges between the locations and is required to file a copy of that rotation schedule with the Circuit Court division of your office.

This designation is intended to fulfill the requirements, specifically, of MSA 27A.1513(2), and shall remain in effect until the further written direction of this Court.
