The Day of Review is for the purpose of reviewing and revising the boundaries of the Thwing and Hutchins Drain Drainage District, and also to review the apportionment of benefit for the Drain for each parcel and municipality within the Drainage District. A map of the proposed Drainage District boundary revisions can be found on the reverse side of this notice and on the Calhoun County website at: http://www.calhouncountymi.gov/government/water_resources/.

The Day of Review is an opportunity to review the Drainage District boundaries and apportionments with the Water Resources Commissioner or a member of her staff. The Water Resources Commissioner, engineers, and other staff members will be available to assist individuals throughout the day, and make revisions where necessary. There is no need to schedule an appointment for a specific time on the Day of Review. The computation of costs for the Drain will also be available at the Day of Review.

Persons with disabilities needing accommodations for effective participation in the Day of Review should contact the Water Resources Commissioner's Office at the number noted above (voice) or through the Michigan Relay Center at 7-1-1 (TDD) at least 24 hours in advance of the Day of Review to request mobility, visual, hearing or other assistance.

You may appeal the Water Resources Commissioner's decision to revise the district boundary to the Calhoun County Circuit Court within ten (10) days, and you may also appeal the determination of apportionments to the Calhoun County Probate Court within ten (10) days.




